



## RÈGLEMENT INTÉRIEUR DU CAMPING NATURISTE « LES ÉTANGS DE SAINT PANCRAS »

---

### 1. Admission and residence conditions

To be allowed to enter, settle or stay on the campsite, you must be authorised by the manager or his representative. Staying on the campsite implies acceptance of the provisions of these rules and the commitment to comply with them. Any infringement may lead to the expulsion of the person responsible. In the event of serious misconduct, the manager may have recourse to the police.

### 2. Police formalities

Anyone who is to stay at least one night in the camp must first present their **identity papers** to the reception desk and complete the formalities required by the police. Minors who are not accompanied by their parents will only be admitted with the written permission of their parents.

### 3. Arrival - Departure

**Arrival at the campsite shall be between 14.00 and 17.00 hours.** The outdoor accommodation and related equipment must be set up on the indicated pitch in accordance with the instructions given by the manager or his representative.

**Departure must be before 12 noon;** holidaymakers are asked to inform the reception office of their departure the day before and to make an appointment between 9 and 11 am for payment. If they intend to leave the campsite before the reception opens, payment must be made the evening before.

It is possible to stay in the common areas outside the arrival and departure times under the sole responsibility of the camper.

### 4. Reception desk

Open from 8.30 a.m. to 8 p.m., with a 24-hour presence of the campsite managers. All the information on the campsite's services, information on the possibilities of provisioning, the tourist attractions of the surroundings and various addresses which may prove useful are accessible there. A system for collecting and processing complaints is available to holidaymakers.

### 5. Display

These rules and regulations are displayed at the campsite entrance and at the reception desk. They can be handed over on request.

### 6. Cost of benefits.

Fees are paid at the reception desk. Their amount is fixed according to the current posted tariff. They are due according to the number of nights spent on the campsite and the low and high season, weekend...

### 7. Noise and silence

Guests are asked to avoid any noise and discussions that might disturb their neighbours.

Sound equipment should be adjusted accordingly. Door and boot locks should be as discreet as possible. Dogs are allowed on a leash and must never be allowed to run at large. They must not be left on the campsite, even locked up, in the absence of their owners, who are civilly responsible for them. **They are not allowed inside the huts.** There must be complete silence between 10 p.m. and 8 a.m.

### 8. Visitors

After having been authorised by the manager, visitors may be admitted to the campsite under the responsibility of the campers who receive them. They must be received at the reception desk by their host.

The services and facilities of the campsite are accessible to visitors. However, the use of these facilities may be subject to a charge, which is displayed at the entrance to the site and at the reception desk. **Visitors' cars must be parked in the outside car park.**

### 9. Traffic and parking of vehicles

Inside the campsite, vehicles must drive, **respecting the priority of pedestrians**, at a speed limited to **10 km/h**. Traffic is forbidden from 10 pm to 7 am. Only vehicles belonging to campers staying at the campsite may circulate within the campsite. Parking is strictly forbidden on pitches other than the one allocated to the camper. Parking must not hinder traffic or prevent the installation of new arrivals. Only one vehicle per pitch is allowed, the others must be parked in the outside car park.

Bicycles and other means of soft mobility are allowed to circulate in the campsite at a reduced speed, respecting the priority of pedestrians.

### 10. Vehicles electric vehicles : bicycles, cars...

The charging of batteries for electric bicycles and scooters can be done on the terminals of the pitches without extension cords or multiple sockets.

**The charging of hybrid or fully electric cars is forbidden from the bollards on the pitches** (major fire risk). A specific Smappee terminal (22KW max with Type 2 cable) is installed in the car park opposite the main toilet block. The connection is made at the request of the camper at the reception. A standard 220v socket is also available. The price is displayed at the reception and on the terminal.

### 11. Maintenance and appearance of facilities

The campsite is designed with **respect for nature, ecology and sustainable development**: cut wood recovered and reused; water saved; LED lighting produced by solar panels; sanitation by planted filter; dry toilets; waste sorting; no use of chemicals; thermal weeding; late mowing **Everyone is required to respect these rules** and refrain from any action that could harm the cleanliness, hygiene and appearance of the campsite and its facilities, particularly with regard to sanitary installations. As **the sanitation is** carried out by phyto-treatment, it is imperative **not to throw in the**

**toilet wipes or sanitary towels.** These must be placed in the bins provided. It is forbidden to throw waste water on the ground. Holidaymakers must empty waste water into the facilities provided for this purpose. Waste of all kinds must be deposited in the bins, respecting the selective sorting (organic waste (compost); recyclable waste (plastic, cardboard, paper); glass; household waste). The **sanitary facilities** must be kept clean by the users. Washing clothes or dishes is strictly forbidden outside the bins provided for this purpose. Washing dishes or laundry is not allowed at the drinking water points. A washing machine and a tumble dryer are available to holidaymakers as well as an iron and an ironing board. To have access to them, please contact the reception, the rates are posted. The hanging of clothes is tolerated near the accommodation, provided that it is discreet and does not disturb the neighbours. It should never be done from the trees. **Plantations and floral decorations** must be respected. It is forbidden to put nails in the trees, to cut branches, to make plantations. It is not permitted to mark out the location of an installation by personal means, nor to dig up the ground. Any damage to vegetation, fences, the campsite or the campsite facilities will be charged to the person responsible. The pitch used during the stay must be maintained in the same condition as the camper found it on arrival.

## 12. Security

### a) Fire.

Open fires (wood, coal, etc.) are strictly forbidden. Stoves must be kept in good working order and not used in dangerous conditions (under a tent or near a car). Alcohol or petrol stoves are not allowed.

The communal barbecue is located next to the reception and is freely available. Wood is available to the user.

In case of fire, notify the management immediately. **Fire extinguishers are available to all.** Their location is indicated in the welcome booklet given on arrival (map)

### b) First aid

A first aid kit is located at the reception desk. A defibrillator (AED) hangs on the wall in the reception area.

The international emergency number is 112.

### c) Vol.

The management has a general obligation to monitor the campsite. Campers are responsible for their own facilities and must report any suspicious persons to the management. Campers are asked to take the usual precautions to safeguard their equipment.

d) *Illegal substances (drugs, etc.), prostitution, soliciting exhibition*

Any use of illegal substances is prohibited and will be reported to the authorities. Prostitution is forbidden and will be subject to exclusion from the campsite, as will soliciting or exhibition.

## 13. Games

No violent or disturbing games may be organised. The management declines all responsibility for any accidents that may occur to the children, who must always be under the supervision of their parents, particularly around the water and at the swimming pool.

### 13. *Swimming pool*

The swimming pool is exclusively reserved for campers. The opening hours, number of bathers and other rules of the pool are posted at the pool. **Nudity is mandatory.**

Any act or behaviour likely to offend decency, good morals or the peace and quiet of the bathers is strictly forbidden. It will be punished by immediate dismissal from the pool. **Please do not use suntan oil in order to respect the environment.**

Animals are strictly forbidden in the pool area. **Showering and foot bathing are compulsory** when entering and leaving the pool.

It is forbidden to enter with shoes.

Eating, drinking, smoking, chewing gum, spitting and littering are not permitted in the pool area.

**The pool is not supervised.** Minors must be accompanied by their parents who are responsible for their own supervision. The management cannot be held responsible for any accidents.

### 14. *Conditions conditions: naturist campsite*

"Les Etangs de Saint Pancras" is a naturist campsite and the naturist ethic must be respected.

Weather permitting, **full nudity is recommended**, while listening to those who may be apprehensive about discovering naturism.

Holidaymakers must behave with the utmost propriety, both inside and outside the campsite. No voyeuristic or exhibitionist behaviour or any conduct likely to shock children or adults will be tolerated.

**Photographs and films** of persons or groups of persons require prior authorisation from the management as well as from the persons photographed.

The offender will be immediately expelled without any recourse.

### 15. *Infringement of the rules of procedure*

In the event that a resident disturbs the stay of other users or does not respect the provisions of these rules, the manager or his representative may orally or in writing, if he deems it necessary, give notice to the latter to cease the disturbance.

In the event of serious or repeated infringement of the internal regulations and after formal notice by the manager to comply, the latter may terminate the contract.

In the event of a criminal offence, the manager may call in the police.
