



## RULES OF PROCEDURE FOR THE NATURIST CAMPSITE ★★★★★ "THE PONDS OF SAINT PANCRAS"

---

### **1. Admission and stay requirements**

To be allowed to enter, settle or stay on the campsite, you must be authorised to do so by the manager or his representative. Staying on the campsite implies acceptance of the provisions of these regulations and the commitment to comply with them. Any violation may result in the expulsion of the offender. In the event of serious misconduct, the manager may have recourse to the police.

### **2. Police formalities**

Anyone who is going to stay at least one night in the camp must first present their identity documents to the person in charge of the reception office and complete the formalities required by the police. Minors who are not accompanied by their parents will only be admitted with the written permission of their parents.

### **3. Arrival - Departure**

**Arrival at the campsite is between 2 pm and 5 pm.** Outdoor accommodation and related equipment must be set up at the location indicated in accordance with the instructions given by the manager or his representative.

**Departure must be before noon;** Holidaymakers are invited to inform the reception desk of their departure the day before it and make an appointment between 9 and 11 a.m. for payment. If they plan to leave the campsite before the reception opens, the payment will be made the night before. It is possible to stay in the common areas outside of arrival or departure times under the sole responsibility of the camper.

### **4. Reception desk**

Open from 8:30 a.m. to 8 p.m., with a 24-hour presence of the managers on the campsite. All information on the campsite's services, information on the possibilities of refuelling, the tourist attractions of the surrounding area and various addresses that may be useful are available there. A system for collecting and processing complaints is available to holidaymakers.

### **5. Display**

These rules of procedure are posted at the entrance of the campsite and at the reception desk. It can be delivered upon request.

### **6. Cost of Services.**

Fees are paid at the reception desk. The amount is set according to the current rate displayed. They are due according to the number of nights spent on the campsite and low and high season conditions, weekends, etc.

### **7. Noise and silence**

Guests are kindly requested to avoid noise and discussions that may disturb their neighbours.

Sound devices must be adjusted accordingly. Door and trunk locks should be as discreet as possible. Dogs are allowed on a leash and should never be allowed to run free. They must not be left at the campsite, even locked up, in the absence of their owners, who are civilly responsible for them. **They are not allowed inside the cabins.** There should be total silence between 10 p.m. and 8 a.m.

### **8. Visitors**

After being authorised by the manager, visitors may be admitted to the campsite under the responsibility of the campers who receive them. They must be received at the reception by their host.

The services and facilities of the campsite are accessible to visitors. However, the use of this equipment may be subject to a fee that is posted at the entrance to the site and at the reception desk. **Visitors' cars must be parked in the outdoor parking lot.**

### **9. Vehicle Traffic and Parking**

Inside the campsite, vehicles must drive at a **speed limit of 10 km/h, respecting the priority of pedestrians.** Traffic is prohibited from 10 p.m. to 7 a.m. Only vehicles belonging to the campers staying on the campsite may circulate in the campsite. Parking is strictly prohibited on sites other than the one allocated to the camper. Parking should not impede traffic or prevent newcomers from settling in. Only one vehicle per pitch is allowed, the others must park in the outdoor car park.

Traffic at reduced speed, bicycles and other means of soft mobility is allowed in the campsite while respecting the priority of pedestrians.

### **10. Electric vehicles: bicycles, cars, etc.**

Electric bike and scooter batteries can be charged at the terminals of the pitches without an extension cord or multiple sockets.

**Charging hybrid or fully electric cars is prohibited from the charging stations on the pitches** (significant risk of fire). A specific Smappee charging station (22KW max with Type 2 cable) is installed in the car park in front of the main toilet block. The connection is made at the request of the camper at the reception. A standard 220v socket is also accessible. The price is displayed at the reception.

### **11. Maintenance and appearance of facilities**

The layout of the campsite is done with **respect for nature, ecology and sustainable development:** wood cut recovered and reused; water saved; LED lighting produced by solar panels; sanitation by planted filter; dry toilets; waste sorting; no use of chemicals; thermal weeding; late mowing **Everyone is required to respect these rules** and refrain from any action that could adversely affect the cleanliness, hygiene and appearance of the campsite and its facilities, especially with regard to sanitary facilities. **As sanitation** is carried out by phyto-purification, it is imperative **not to flush wipes or sanitary napkins down the toilet.** These must be placed in the bins provided for this purpose. It is forbidden to dispose of sewage on the ground. Holidaymakers must empty waste water in the facilities provided for this purpose. Waste of any kind must be deposited in the bins in accordance with selective sorting (organic waste (compost); recyclable waste

(plastic, cardboard, paper); glass; household waste). Sanitary **facilities** must be kept clean by users. Washing clothes or dishes is strictly forbidden outside the bins provided for this purpose. Washing up or washing up is prohibited at drinking water terminals. A washing machine and dryer are available for guests' use, as well as an iron and a table. To get access to it, ask at the reception, the rates are displayed. Hanging laundry is tolerated near the accommodation, provided that it is discreet and does not disturb the neighbours. It should never be made from trees. Plantings **and floral decorations** must be respected. It is forbidden to drive nails into trees, to cut branches, to make plantations. It is not permitted to delineate the location of a facility by personal means, nor is it permitted to dig the ground. Any damage to vegetation, fences, campsite or campsite facilities will be the responsibility of the perpetrator. The pitch that has been used during the stay must be maintained in the condition in which the camper found it when entering the premises.

## 12. Security

### *(a) Fire.*

Open fires (wood, coal, etc.) are strictly prohibited. Stoves must be kept in good working order and not used in hazardous conditions (under a tent or near a car). Alcohol or gasoline stoves are not permitted.

The communal barbecue is located next to the reception and is free to access. Wood is available to the user.

In the event of a fire, notify management immediately. **Fire extinguishers are available to everyone.** Their location is specified on the welcome booklet given on arrival (map)

### *(b) First aid*

A first aid kit is available at the reception desk. A defibrillator (AED) hangs on the wall of the reception.

The international emergency number is 112.

### *(c) Theft.*

The management has a general obligation to supervise the campsite. The camper remains responsible for his/her own installation and must report to the person in charge the presence of any suspicious person. Holidaymakers are invited to take the usual precautions to safeguard their equipment.

*(d) Illicit substances (drugs, etc.), prostitution, solicitation, exhibitions*

Any use of illegal substances is prohibited and will be reported to the authorities. Prostitution is prohibited and will be excluded from the campsite, as well as soliciting or exhibiting.

## 13. Games

No violent or annoying games can be arranged. The management declines all responsibility in the event of an accident that may occur to children, who must always be under the supervision of their parents, especially around bodies of water and at the swimming pool.

## 13. Swimming Pool

The swimming pool is exclusively reserved for campers. Opening hours, number of bathers and other pool rules are posted at the pool. **Nudity is mandatory.**

Any act or behaviour likely to undermine the decency, good morals and tranquillity of bathers is strictly prohibited. It will be sanctioned by immediate dismissal from the pool. **Please do not use sunscreen oil to respect the environment.**

Pets are strictly forbidden in the pool area. **Showering, as well as passing through the footbath, are mandatory** when entering and leaving the pool.

It is forbidden to enter with shoes.

It is forbidden to eat, drink, smoke, chew gum, spit and throw rubbish in the pool area.

**The pool is not supervised.** Minors must be accompanied by their parents, who are the sole guardians of them. Under no circumstances can the management be held responsible in the event of an accident.

## 14. Special conditions: naturist campsite

"The Ponds of Saint Pancras" is a naturist campsite, naturist ethics must be respected.

If the weather permits, **full nudity is recommended**, while remaining attentive to people who may have apprehensions about discovering naturism.

Holidaymakers must behave with the utmost correctness, both inside and outside the estate. No voyeuristic or exhibitionist behaviour or any behaviour likely to shock children or adults will be tolerated.

Photographs and **films** of persons or groups of persons must be subject to prior authorization from the management as well as from the persons photographed.

The offender will be immediately deported without any recourse.

## 15. Violation of the Rules of Procedure

In the event that a resident disturbs the stay of other users or does not comply with the provisions of these internal regulations, the manager or his representative may, orally or in writing, if he deems it necessary, give formal notice to the latter to cease the disturbances.

In the event of a serious or repeated breach of the internal rules and after formal notice by the manager to comply with them, the latter may terminate the contract.

In the event of a criminal offence, the manager may call on the police.
